- GCE 'O' Level Science (Physics) grade C6 or Physics Bridging Course
- WSH skills and knowledge equivalent to that of Advanced Certificate in WSH
- At least 2 years of post- qualification working experience as WSH Supervisor, Coordinator or similar role **OR** at least 5 years of WSH related working experience, in which 2 years should be recent.
